

The Rock County Board of Commissioners met at 7:00 a.m. at the county road shop as advertised. Present were Commissioners Stout & May. Absent: Craven. Road employees were: Darrell Olson, road foreman, Mitch Dean, Jeff Kinney, Waylon Reynolds, Lorn Schmitz, Tony Stahl & Mike Turpin. Road matters were discussed. Meeting was adjourned at 8:00 a.m.

The Rock County Board of Commissioners met at 9:00 a.m. as advertised. The meeting was called to order by Chairman Stout at 9:00 a.m. Roll call was taken. Present were Stout & May; Absent: Craven Also present was Daunitta Buoy, County Clerk.

The agenda for the day was reviewed. Motion made by May and seconded by Stout to approve the agenda as posted in the Clerk's office. Roll call vote: May – Yes Stout – Yes Craven - Absent. Motion carried.

The minutes of the January 21, 2020 meeting were presented. Motion made by May and seconded by Stout to approve the minutes as presented. Roll call vote: May – Yes Stout – Yes Craven - Absent Motion carried.

Stout stated the Open Meeting Law is posted on the wall.

Motion by Stout and seconded by May to approve Sheriff's January Fee Report. Roll call vote: May – Yes Stout – Yes Craven - Absent Motion carried.

Motion by Stout and seconded by May to approve Clerk & Clerk of District Court January Fee Report. Roll call vote: May – Yes Stout – Yes Craven - Absent Motion carried.

2 applications were received for part time custodial position. Motion by Stout and seconded by May to hire Casey Magary at \$15.00/hr. for the part time custodian. Roll call vote: May – Yes Stout – Yes Craven - Absent Motion carried.

Motion by Stout and seconded by May to approve .575 mileage rate which is approved by the State Auditor's Office for 2020 for County Employees. Roll call vote: May – Yes Stout – Yes Craven - Absent Motion carried.

3 quotes were received for a V Plow for the pay loaders. Motion by Stout and seconded by May to accept Henke's quote of \$14653 plus shipping and handling. Roll call vote: May – Yes Stout – Yes Craven - Absent Motion carried.

Commissioners discussed the sale of surplus property. Tabled to next meeting.

Commissioners reviewed petition received from Frank Taylor. No action taken. A. Gurnsey, County Attorney will review and advise.

TJ Ellermeier, Assessor met with the Commissioners on Permissive Exemption Applications. There were no new Applications filed. Motion by May and seconded by Stout to accept permissive applications published and presented. Roll call vote: May – Yes Stout – Yes Craven - Absent Motion carried.

TJ Ellermeier, Assessor and M. Davis, Treasurer met with the Commissioners on an error on tax credit calculations. Treasurer will reissue corrected tax statements. Anyone who has already paid the 1st half will have a credit on the 2nd half of their taxes. If it was paid in full there will be a refund issued as soon as the money is available.

Commissioners reviewed the BKR Extension Annual Report.

S. Davis & T. Becker, met with the Commissioners to discuss obtaining a bond for a new swimming pool. There are grants available, but before they can apply, a Bond must be in place. The grants will shorten the length of the Bonds. Commissioners agreed that we should place it on the ballot to be voted on in the Primary by the County.
