

The Rock County Board of Commissioners met at 7:00 a.m. at the county road shop as advertised. Present were Commissioners Hollenbeck & May. Absent: Stout. Road employees were: D. Olson, road foreman, W. Cole, M. Dean, J. Kinney W. Reynolds, T. Stahl & M. Turpin. Road matters were discussed. Meeting adjourned at 8:00 a.m.

The Rock County Board of Commissioners met at 9:00 a.m. as advertised. The meeting was called to order by Chairman Stout at 9:20 a.m. Roll call was taken. Present were Stout, Hollenbeck & May. Also present were D. Olson, Road Foreman & D. Buoy, County Clerk.

The minutes of the February 16, 2021 meeting were presented. Motion made by Hollenbeck and seconded by May to approve the minutes as presented. Roll Call Vote: All For None Against Motion carried.

The agenda for the day was reviewed. Motion made by May and seconded by Hollenbeck to approve the agenda as posted in the Clerk's office. Roll call vote: All For None Against Motion carried.

Stout stated the Open Meeting Law is posted on the wall in the Commissioner's room.

D. Olson, Road Supervisor discussed road updates. Hollenbeck attended a meeting at the Carn's Bridge with NDOR and gave updates on the Carn's Bridge Project.

Motion by May and seconded by Stout to approve a lease for a tract in the SE4SE4 of Sec. 24, Twp. 28N, Rg. 18, W of the 6th P.M., Rock Co., NE. Roll call vote: All For None Against Motion carried.

J. Anderson, Sheriff & A. Gurnsey, County Attorney met with the Commissioners on trees and debris on a road between Sections 26 & 27 & Sections 34 & 35, Twp. 30N, Rg. 18, W of the 6th P.M., Rock Co., NE. The debris has been removed so no action taken.

The Commissioners discussed the Resolution from Brown County to withdraw from the Region 24 Interlocal. Also present were Doug Fox, Emergency Manager, Caleb Johnson & Cathy Doke. JEO billing for Brown County's share of the Hazard Mitigation was also discussed.

Caleb Johnson met with the Commissioners on the upcoming 21/22 budget renewal contract with the County. Motion by May and seconded by Stout to approve the contract for the 21/22 & 22/23 budget years for \$2600.00/year. Roll call vote: All For None Against Motion carried.

Fee reports were presented to the Commissioners. Motion by Stout and seconded by May to approve the Sheriff Fee Report. Roll call vote: All For None Against Motion carried. Motion by May and seconded by Stout to approve Clerk & Clerk of the District Court Fee Reports. Roll call vote: All For None Against Motion carried.

A. Grant met with the Commissioners on safety committee concerns.

M. Davis, Treasurer met with the Commissioners on a Journal entry that needed made to move money from the 2915 Fund to the 2500 Fund. Motion by Stout and seconded by Hollenbeck to move \$3083.33 from 2915 Emergency Management Fund to 2500 Hazard Mitigation Fund. Roll call vote: All For None Against Motion carried.
