Also present was Darrell Olson, road foreman, J. Kinney, L. Schmitz, T. Stahl, J. Reynolds, W. Reynolds & M. Turpin. Road matters were discussed. Meeting adjourned at 8:00 a.m.

The Rock County Board of Commissioners met at 9:00 a.m. as advertised. The meeting was called to order by Chairman Stout at 9:00 a.m. Roll call was taken. Present were Stout, May & Craven. Also present was Daunitta Buoy, County Clerk & Commissioner Candidate Wade Hollenbeck.

The agenda for the day was reviewed. Motion made by Craven and seconded by May to approve the agenda as posted in the Clerk's office. Roll call vote: All in favor. None opposed. Motion carried.

The minutes of the May 5, 2020 meeting were presented. Motion made by May and seconded by Craven to approve the minutes as presented. Roll call vote: All in favor. None opposed. Motion carried.

Stout stated the Open Meeting Law is posted on the wall in the Commissioner's room.

The interested party requesting to start the process of the vacation of the street lying between Lots 1-10 & Lots 14, 15, 16, 17 & 11 of Blk. 7 Swanson Subdivision withdrew their request.

Motion by Stout and seconded by May to stay with Blue Cross Blue Shield Insurance and the current insurance deductible of \$1500 for 20/21 Fiscal Year. Roll call vote: All in favor. None opposed. Motion carried.

Tax Equalization & Review Commission sent correspondence stating that the levels of value for real property in Rock County for the tax year 2020 met the requirements of law.
