EXPLANATION: A vote for this proposition: Would result in the requirement that the office of County Surveyor, on either a full-time or part-time basis, as determined by the Rock County Board of Commissioners would be elected by the voters of the county at the statewide General Election beginning in 2024 and each four years thereafter. A vote against this proposition: Would result in the office of County Surveyor ceasing as an elected office with the expiration of the term of the current Surveyor, or shall remain as it exists if no elected Official holds that office. In that event, the office would be filled by the Rock County Board of County Commissioners appointing a county surveyor as currently done.
