D. Olson, Road Foreman met with the Commissioners on road updates. Roads needing gravel were discussed. The 143H road grader that needs repaired was discussed. The part needed won't be available until January, 2024. CAT converted it from 6 wheel drive to rear wheel drive, so it can be used. Purchasing clay from the Zeman pit was discussed. Motion by Hollenbeck and seconded by Sybrant to approve purchasing clay from Zeman for \$3.50/yd. Roll Call Vote: All For None Against Motion carried. Olson also discussed the need to purchase a new road grader. They want to be on a 3 year rotation to keep the equipment updated. Motion by Hollenbeck and seconded by Sybrant to advertise for sealed bids for a new road grader. Roll Call Vote: All For None Against Motion carried.

Ally Grant, NIRMA Representative awarded the winners of the Fitness Challenge. 1st Crystal Sell – 2nd Lacey Friedrich – 3rd Waylon Reynolds. She also presented the quotes received for the roofing on the weed shed. Quotes were received from Buffalo Roofing – (Shingles) \$14,881.75, May Construction – (Metal Roofing) \$15,000.00 & Weathercraft Co –(Shingles) \$13,000.00. Motion by Hollenbeck and seconded by Sybrant to approve May Construction's quote of \$15,000.00 for a metal roof. Roll Call Vote: All For None Against Motion carried. Ally also discussed the drug tests that she administers to the road department. Her license expires in 2024.

Correspondence was received from U.S. Department of Transportation. They have received an extension to September 30, 2024 for the Carn's Bridge project. Concerns are that with each extension the costs will continually increase from the original estimate.

Fee reports were discussed. Motion by Hollenbeck and seconded by Sybrant to approve the September Fee Reports for Sheriff, Clerk & Clerk of the District Court. Roll Call Vote: All For None Against Motion carried.

Jim Anderson met with the Commissioners on the generator & contract with CAT for the Courthouse & Hospital. CAT performs a yearly inspection. CAT had contacted him, so he was passing the maintenance information on.

The Commissioners discussed the roads not mowed by October 1st, 2023. Hollenbeck will talk to K. Arganbright, County Attorney about how to proceed contracting mowing of the roads that aren't in compliance with the October 1st deadline & the procedure to add the mowing of the roads to the land owners taxes.
