Rent to the City for the Ambulance Barn was discussed. There is no formal contract between the City & County for rent. This project can't totally be validated. Rock County will have to return \$219,922.44 to FEMA from funds previously received. This money is not part of our tax levy.

TJ Ellermeier, Assessor/Zoning Administrator met with the Commissioners on zoning updates. AK Investments have submitted permits for hog barns in 2 different locations East of Rose. Their permits were incomplete, so TJ returned them to be completed.

Mona Davis, Treasurer, TJ Ellermeier, Assessor & Kurt Arganbright, County Attorney were present for the Audit Exit Interview. Also present was Jake Fusselman, State Auditor's Office. The audit will be noticed in the paper when available for public inspection in the Clerk's office.

Kurt Arganbright, County Attorney discussed applications for road crossing & parallel occupancy permits on county road right-of-ways. Also present was Ally Grant, NIRMA Representative. Kurt's concern is private individuals allowed to do a road crossing. There is an issue with people proceeding without an application or permit from the County Board. The concern is what the counties liability is. Ally will check with NIRMA about the liability concern.
