

The Rock County Board of Commissioners meeting was advertised in the Rock County Leader on May 13, 2026. The meeting was called to order by Chairman Hollenbeck at 9:00 a.m. as posted. Roll call was taken. Present were Commissioners Wade Hollenbeck, Faye Smith & Colby Sybrant. Also present was Daunitta Buoy, Clerk.

Hollenbeck stated the Open Meeting Law is posted on the wall in the Commissioners room.

The agenda for the day was reviewed. Motion by Smith and seconded by Sybrant to approve the agenda as posted in the Clerk’s office. Roll Call Vote: All For None Against. Motion carried.

The minutes were presented to the Commissioners for the May 5, 2026 regular meeting, published May 13, 2026. Motion by Sybrant and seconded by Smith to approve the minutes for the May 5, 2026 regular meeting as presented. Roll Call Vote: All For None Against. Motion carried.

Joe Contreres met with the Commissioners on his payroll. Between the 3 different jobs, he receives 3 different checks. Clerk will look into combining checks.

Macey Lackaff, Library Director met with the Commissioners with her 26/27 budget. Matter tabled until Budget meeting.

The Commissioners interviewed a road applicant. Motion by Hollenbeck and seconded by Sybrant to approve Jacob Walton for the advertised road position at \$20.00 per hour, then after probation of 6 months \$\$21.75. Roll Call Vote: All For None Against. Motion carried.

Casey Foster, Bassett Country Club met with the Commissioners for approval of a Special Designated Liquor License for the June Expo held June 16-18, 2026. Motion by Smith and seconded by Sybrant to approve the SDL for the Bassett Country Club for the June Expo. Roll Call Vote: All For None Against. Motion carried.

Insurance Premiums from Blue Cross Blue Shield for the 26/27 fiscal year were discussed. A single premium raised to \$1434.62. Motion by Smith and seconded by Hollenbeck to approve NACO’s insurance rate of \$1434.62 for 26/27 budget year for a single policy or reimbursement for a single policy. Roll Call Vote: All For None Against. Motion carried.

The correspondence received from the Garfield County Commissioners regarding concerns of our Rock County Sheriff’s Department traveling through their county was discussed. Ben Shelbourn, Sheriff, Jacob Gardner, Deputy, Derek White, Deputy & Kurt Arganbright, County Attorney were also present. Ben had dashcam video that proved that there was not the concern that Garfield County had claimed. The Commissioners will send a letter to Garfield County Commissioners along with a thumb drive with the dash cam video. There is statute in place that allows help between counties without an interlocal.
