ROCK COUNTY BUDGET DOCUMENT
RESOLUTION OF ADOPTION AND APPROPRIATIONS AS AMENDED

WHEREAS, A proposed County Budget for the fiscal year of July 1, 2020 to June 30, 2021, prepared by the Budget Making Authority, was adopted by the Rock County Board of Commissioners on the 15th day of September, 2020; and

WHEREAS, Expenses to pay for hazard mitigation planning within the Hazard Mitigation Fund 2500 is anticipated to exceed the budgeted expenditures approved within the Budget Document approved on September 15, 2020 by \$74,000.00; and

WHEREAS, It is the desire of the Rock County Board of Commissioners account for additional anticipated revenue within the Hazard Mitigation Fund 2500 by 74,000.00 from the following various sources: \$4,000.00 transferred from the General Fund 100, \$55,000.00 anticipated from the State of Nebraska and \$15,000.00 from other Local Resources.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Rock County, Nebraska as follows:

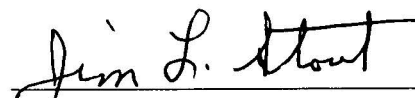
SECTION 1. That the amended budget for the fiscal year of July 1, 2020 to June 30, 2021, as categorically evidenced by the Amended Budget Document be, and the same hereby is adopted as the Amended Budget for Rock County for the said fiscal year.

SECTION 2. That the offices, departments, activities and institutions herein named are hereby authorized to expend the amounts herein appropriated to them during the fiscal year beginning July 1, 2020, and ending June 30, 2021.

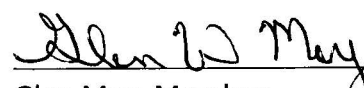
SECTION 3. That the income necessary to finance the appropriations made and expenditures authorized shall be provided out of the unencumbered cash balance in each fund, revenues other than taxation to be collected during the fiscal year in each fund, and tax levy requirements for each fund.
