

RESOLUTION 2021- 25
PROPERTY TAX REQUEST 2021-2022

WHEREAS, Nebraska Revised statute 77-1601.02 provides that the property tax request for the prior year shall be the property tax request of the current year for purposes of the levy set by the County Board of Equalization unless the Governing body of Rock County passes by a majority vote a resolution setting the property tax request at a different amount; and

WHEREAS, this action can only be taken after a special public hearing, as required by law, to hear and consider comments concerning the property tax, and

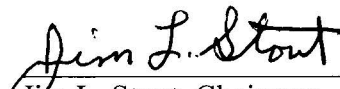
WHEREAS, it is in the best interests of Rock County that the property tax request for the current year be a different amount than the property tax request for the prior year.

NOW THEREFORE BE IT RESOLVED, the Governing Body of Rock County have the property tax request be set as follows for each Rock County Fund which directly receives property taxes as all or a portion of its revenue.

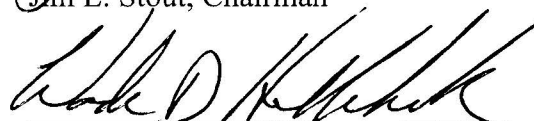
1. The 2021-2022 property tax request for the General Fund be set at \$1,827,479.33 which is different than the 2020-2021 Property Tax asking of \$1,900,215.80.
2. The 2021-2022 property tax request for the Library Fund be set at \$112,959.05 which is different than the 2020-2021 Property Tax asking of \$112,232.10.
3. The 2021-2022 property tax request for the Road Bond Fund be set at \$291,137.05 which is different than the 2020-2021 Property Tax asking of \$291,157.18.
4. The 2021-2022 property tax request for the Other Capital Projects Fund be set at \$0.00 which is different than the 2020-2021 Property Tax asking of \$63,042.79.
5. The 2021-2022 property tax request for the Hospital Fund (5000) be set at \$0.00 which is different than the 2020-2021 Property Tax asking of \$306,475.24.
6. The 2021-2022 property tax request for the Hospital Tax Collection Fund (5001) be set at \$306,718.78 which is different than the 2020-2021 Property Tax asking of \$0.00, as it is a New Fund.
7. The 2021-2022 property tax request for the Hospital Bond Fund be set at \$132,173.91 which is different than the 2020-2021 Property Tax asking of \$132,948.33.
8. The 2021-2022 property tax request for the Ambulance Replacement Fund be set at \$66,142.43 which is different than the 2020-2021 Property Tax asking of \$65,916.00.
9. The total assessed value of property differs from last year's total assessed value by .34%.
10. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be .434213 per \$100 of assessed value.
11. The Rock County Board of Commissioners proposes to adopt a property tax request that will cause its tax rate to be .413745 which is different than the 2020-2021 tax rate of .435705, per \$100 of assessed value.
12. Based on the proposed property tax request and changes in other revenue, the total operating budget of the Rock County Board of Commissioners will **decrease** compared to last year's operating budget by .54%.
13. A copy of this resolution be certified and forwarded to the County Clerk on or before October 13, 2021.

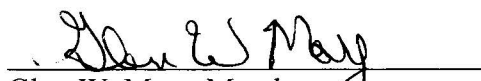
